**Note: Painting your home using the same approved colors DOES NOT NEED ARC approval, but approval IS REQUIRED if the manufacturer colors are not known or are no longer available.**

The following checklist should be used to confirm you have provided the information required for the ARC to review your project in a timely manner:

- Photograph of the front, back, and both sides of your home, including "line of sight" from the golf course if your home backs up to the golf course.
- Photographs of adjacent neighbors' homes on each side and directly/diagonally across from your home.

Proposed colors for the project - manufacturer, color name, **AND** color number for **each paint color and** area to be painted. i.e., color names for the body, trim, shutters, and doors, etc. *Example: SW 7036*

Samples of paint colors to be used - you **must submit** actual paint color samples to the office. *The manufacturer small "chip" sample is preferred. Samples should be no more than 5x7 inch in size* (neutral and earth tones are required when applicable). A custom color paint sample should be done on a **small** piece of white art paper, wood siding, vinyl, or other material with a neutral or white background (do not paint on colored paper or cardboard as this will not provide a true color sample). Deliver the small samples of the custom colors to the office along with your request. **Photographs or an email of paint colors are NOT acceptable.**

Projects begun without ARC approval are subject to fines.
